VI. REPORTS/CORRESPONDENCE

A. AGENCY REPORTS

1. Reports from cities

Wasilla City

Councilmember Koskela:

- spoke regarding the easements for the Creekside Town Square development that the Assembly will be addressing at their next meeting;
- noted that the developer is here to provide the Assembly with an overview of the project; and
- urged the Assembly to look at approving the easements.

Mr. Jack Barrett, Meritage Development Group, LLC:

- spoke regarding the need for retailers within the city of Wasilla;
- reported on the development plans;
- noted that the development would create 1,050 to 1,200 jobs; and
- spoke regarding the issue with the quantity of liquor licenses within the city of Wasilla.

2. Matanuska-Susitna Borough School District

Mr. Troxel, Chief School Administrator:

- stated that the School District has worked hard to plan for the future over the last five years; and
- spoke regarding the process that the School District has used for performance-based budgeting.

The following principals provided a report on the small schools' performance-based budgeting: Ms. Alberta Norberg, Willow Elementary School; Ms. Katherine Fennel, Sutton Elementary School; Ms. Wendy Taylor, Glacier View Elementary School; and Mr. Chris Hager, Talkeetna Elementary School and Trapper Creek Elementary School.

Assemblymember Allen queried the number of the students in the kindergarten and music classes at each school.

The principals reported the numbers of students in the kindergarten and music classes in their schools.

Assemblymember Woods:

- commented that two of the small schools are within her assembly district;
- spoke regarding the difficulties with the funding for small schools; and
- noted that the residents within the small communities place a high value on the small schools.

Assemblymember Church:

- advised that the Assembly is considering placing a boroughwide sales tax on the ballot due to the revenue shortfalls; and
- queried whether the principals would be interested in a boroughwide sales tax.

Mr. Hager advised that he, personally, would support a sales tax for the overall welfare of the community.

C. MANAGER COMMENTS

1. State/Federal Legislation

Mr. Duffy:

- spoke regarding the Borough services telephone survey;
- advised that Superintendent Paul Anderson will not be moving forward with designating the Denali Park and Preserve as a World Heritage Site;
- spoke regarding a letter that was received from Mr. Rex Turner in regards to the extension of Trunk Road;

- spoke regarding updating the State Legislative Delegation from the Kenai Peninsula Borough and the Fairbanks North Star Borough regarding the rail line extension; and
- spoke to the need for assembly members to be in Juneau every two weeks while the Legislature finalizes their session.

Assemblymember Bettine:

- queried if there was a specific message that needs to get out with regards to the Boroughs state priority list; and
- spoke regarding the issues with PRS/TERS,

Mr. Duffy:

- advised that he and the Mayor would be meeting with the Municipality of Anchorage and the Kenai Peninsula Borough to discuss the issues;
- stated that the Alaska Municipal League has hired Mr. Gillespie to push revenue sharing; and
- opined that the Borough has been clear regarding the need for the senior citizens and disabled veteran exemptions being funded and the need for revenue sharing.

Assemblymember Bettine:

- noted that some of the elected state officials believe that they are providing revenue sharing by funding schools and road projects; and
- requested that the Manager provide a fact sheet so that the Assembly members can speak to these issues with the Legislators.

Assemblymember Kvalheim spoke to the need to educate the public so that they can also let the Legislators know that they support the funding.

Discussion ensued regarding:

Mr. Duffy advised that the industry title for this position is “Chief Information Officer.”

Assemblymember Kvalheim queried whether Geographic Information Systems (GIS) would stay under the IT Department.

Ms. Romano advised that GIS would stay under the IT Department.

Discussion ensued regarding:

- the services that will be provided.

Mayor Menard opened the public hearing.

Ms. McGehee provided a staff report.

Assemblymember Bettine queried the reason for the non-refundable cash fee.

Ms. McGehee advised that there was a candidate, in the last election, that filed for candidacy with a check that ultimately failed to clear, and the action resulted in a disqualification of the candidacy.

Assemblymember Bettine spoke regarding the need for the candidates to track their payments.

Ms. McGehee:

- advised that she spoke to this issue with the Alaska Public Offices' Commission (APOC); and
- noted that APOC does not require funds in this small of an amount, for this purpose, to be tracked.

Assemblymember Kluberton:

- noted that the filing fee is a pre-campaign expense that does not need to be tracked; and
- spoke regarding the problems that a bounced check can cause.

Ms. McGehee:

- advised that in this case, the ballots were already in the process of being printed when the Clerk's Office was not made aware of the matter until three weeks later; and
- noted that it would have cost the Borough \$15,000 to reprint the ballots.

Mayor Menard opened the public hearing.

There being no one present who wished to testify, the public hearing closed and discussion moved to the Assembly.

MOTION: Assemblymember Kluberton moved to adopt Ordinance Serial No. 07-032.

MOTION: Assemblymember Bettine moved a primary amendment to Ordinance Serial No. 07-032, MSB 25.15.030(D), by striking the word “cash” throughout that subsection to read as follows: (D) A non-refundable \$25 fee shall accompany each declaration of candidacy for the office of mayor, assembly seats, and school board seats to help defray administrative costs of holding the election. If a candidate withdraws a declaration for one seat or office to file for another seat or office, in accordance with MSB 25.15.055, an additional non-refundable \$25 filing fee shall be collected by the clerk’s office. An application showing proof of indigence may be completed, and submitted to the clerk for approval, by candidates requesting waiver of the filing fee.

VOTE: The primary amendment failed with Assemblymembers Bettine, Allen, and Wells in support.

VOTE: The main motion passed without objection.

MOTION: Assemblymember Allen moved to adopt Resolution Serial No. 07-040.

Ms. Clayton provided a staff report.

Assemblymember Allen queried the original administrative fee to the State.

Ms. Clayton advised the administrative fee is 10 percent.

Assemblymember Allen queried how the \$686,000 will be used.

Ms. Clayton advised that the funds will be used to cover the administrative fee, as it will need to be audited for the next three years, for the project manager's wages and construction incentives;

Mr. Duffy advised that the remaining funds will go into construction.

Assemblymember Bettine queried the right-of-way issues.

Mr. Duffy:

- advised that there was never an as-built survey performed when the road was built in 1987; and
- spoke regarding the areas of the road that may have issues when the construction begins.

Assemblymember Bettine queried when the pavement will occur.

Mr. Duffy advised that the pavement may occur in June 2008.

VOTE: The motion passed without objection.

- c. AM No. 07-054: APPROVAL OF CHANGE ORDER TO UNIT COMPANY IN AN AMOUNT NOT TO EXCEED \$3,000,000 FOR ADDITIONAL WORK TO THE KNIK-GOOSE BAY ELEMENTARY SCHOOL DESIGN/BUILD PROJECT, PROJECT NO. 40161.

MOTION: Assemblymember Allen moved to approve AM No. 07-054.

Mr. Rountree provided a staff report.

Assemblymember Woods queried the septic and leach field.

Mr. Rountree:

- advised that the Shaw Elementary School prototype was used for this school;
- stated that the civil work was bid on separately than the construction of the school; and
- advised that the Borough is not paying more for the septic and leach field just because the civil work was not included in the base bid.

Assemblymember Woods:

- spoke to the issues of the public seeing a change order in the amount of \$3,000,000; and
- stated that a lot of the public does not attend the meetings to hear the explanations for the change orders.

Discussion ensued regarding:

- how the funds can be used;
- the issues with Hollywood road;
- concerns with the amount of the change order; and
- safety issues that the staff and the contractor have addressed.

MOTION: Assemblymember Bettine moved a primary amendment to AM No. 07-054 as follows:

1. by reducing the change order amount throughout the legislation from “\$3,000,000” to “\$1,978,195;”
2. to strike and insert the following at the end of paragraph five: strike “The bid opening could get delayed depending upon how many bids were received. Since bids have not been opened yet, and given the need for the school to be opened by August 2007, the Department of Public Works is requested Assembly approval of a change order at this time that will not exceed \$3,000,000. When the low bid is received, this information will be readily divulged to the Assembly” and insert in its place “After the bid process was completed, the contractor received three competitive bids from three qualified bidders and the lowest qualified bidder was Wilder Construction Company with a bid of \$1,978,195 for the on-site work;” and
3. to strike the amount of “\$15,034,377 in the last paragraph and insert in its place “\$14,012,572” to read as follows: Funding for this change order is currently available from the 2006 Serial A General Obligation School Bonds. If approved, this change order will be the forth change order issued for this contract and will increase the total contract amount of \$14,012,572.

VOTE: The primary amendment passed without objection.

VOTE: The main motion passed as amended without objection.

- advised that the Talkeetna Sewer and Water SSA has begin to make payments on both of the loans;
- stated that some of the issues with the service area have been resolved; however, not all of the issues; and
- advised that penalties are being charged, water is being cutoff, and more people are coming online.

Discussion ensued regarding:

- the remaining issues with the Talkeetna Sewer and Water SSA;
- the need for an analysis to be performed to see what the Borough has fixed over the life of the system;
- the need for a dedicated administer for the system; and
- the need for Talkeetna to have a community water system.

MOTION: Assemblymember Church moved to postpone AM No. 07-055 to a time certain of April 17, 2007.

VOTE: The motion to postpone to a time certain of April 17, 2007, passed without objection.
