MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 07-119

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY REAPPROPRIATING \$25,000 FROM THE DUST CONTROL PROGRAM, PROJECT NO. 35000, FUND 410, TO FUND 415, FOR THE TALKEETNA SEWER AND WATER REPAIRS, UPGRADE, AND EXPANSION PROJECT, PROJECT NO. 25037, TO ALLOW FOR THE REPAVING OF B STREET.

WHEREAS, the State of Alaska Department of Environmental Conservation approved a grant for the Talkeetna Sewer and Water Repairs, Upgrade, and Expansion Project in the amount of \$1,879,600; and

WHEREAS, the grant was accepted and appropriated by the Assembly on October 15, 2002, with the adoption of Ordinance Serial No. 02-116; and

WHEREAS, the grant requires a 100 percent match; and

WHEREAS, Resolution Serial No. 02-097 identified the scope of work and budget for \$1,300,000 of these funds as well as matching funds from a federal grant from the United States Department of Agriculture (USDA); and

WHEREAS, Resolution Serial No. 03-095 identified the scope of work and budget for \$50,000 of these funds as well as matching funds from the revolving loan fund; and

WHEREAS, Resolution Serial No. 06-047 identified the scope of work and budget for \$475,000 of these funds as well as matching

funds from a federal grant from the Environmental Protection Agency (EPA); and

WHEREAS, it is necessary to repave B Street to return the street to its original condition prior to the freeze protection of waterlines; and

WHEREAS, the cost for the repave of B street is estimated to be \$50,000; and

WHEREAS, matching funds for an additional \$25,000 of the grant from the Alaska Department of Environmental Conservation is now available from the fiscal year 2008 areawide appropriation to the dust control program, project no. 35000, fund 410; and

WHEREAS, no expenditures can be made until an amended scope of work and budget has been approved by the Assembly.

BE IT ENACTED:

Section 1. <u>Classification</u>. This is a non-code ordinance.

Section 2. <u>Reappropriation source</u>. There is hereby reappropriated by the Matanuska-Susitna Borough Assembly \$25,000 from the Dust Control Program, project no. 35000, fund 410, to fund 415, for the Talkeetna Sewer and Water Repairs, Upgrade, and Expansion Project, project no. 25037, to allow for the repaving of B Street.

Section 3. <u>Effective date</u>. This ordinance shall take effect upon adoption by the Matanuska-Susitna Borough Assembly.
