MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 07-126

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$63,188 FROM THE UNITED STATES FISH AND WILDLIFE SERVICE FOR THE FISH PASSAGE CONSTRUCTION PROJECT ON GOVERNMENT CREEK AT EDGERTON PARK ROAD, PROJECT NO. 30084, FUND 410.

WHEREAS, the United States Fish and Wildlife Service approved a grant project as part of the National Fish Habitat Initiative Program in the amount of \$63,199 for the Government Creek at Edgerton Park Road Project to replace a substandard culvert to ensure fish passage and adequate drainage; and

WHEREAS, the total estimated cost of the project is \$108,188; and

WHEREAS, the Borough is required to provide \$40,000 in matching funds and \$5,000 of in-kind services toward this project; and

WHEREAS, funds in the amount of \$6,437,400 from the Alaska State Department of Commerce, Community, and Economic Development were accepted and appropriated by the Assembly on August 18, 2006, with Ordinance Serial No. 06-152; and

WHEREAS, Resolution Serial No. 06-151 identified \$242,494 of the above grant funds for the South Colony Road Service No. 16; and

WHEREAS, \$40,000 of these funds were identified for the Government Creek at Edgerton Park Road fish passage project which lies within the South Colony Road Service Area; and

WHEREAS, the Assembly must approve an ordinance to accept and appropriate these grant funds prior to expenditures; and

WHEREAS, no expenditures can be made until the scope of work and budget has been approved by the Assembly.

BE IT ENACTED:

Section 1. Classification. This is a non-code ordinance.

Section 2. <u>Acceptance and appropriation source</u>. There is hereby accepted and appropriated by the Matanuska-Susitna Borough Assembly, \$63,188 from the United States Fish and Wildlife Service to Fund 410, project no. 30084, for the Fish Passage Construction Project on Government Creek at Edgerton Park Road.

Section 3. <u>Effective date</u>. This ordinance shall take effect upon adoption by the Matanuska-Susitna Borough Assembly.
