**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 07-149**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING, APPROPRIATING A GRANT IN THE AMOUNT OF \$1,395,000 FROM THE ALASKA STATE DEPARTMENT OF COMMERCE, COMMUNITY AND ECONOMIC DEVELOPMENT, TO FUND 405, PROJECT NOS. 45226, 45227, 45228, 45210, 45066, AND 45211 FOR PURCHASE OF VARIOUS FIRE FIGHTING AND COMMUNICATION EQUIPMENT, APPARATUS, SHELTERS AND BUILDING REPAIRS.

WHEREAS, the Matanuska-Susitna Borough was notified of a grant award in the amount of \$1,395,000 from the Alaska State Department of Commerce, Community and Economic Development; and

WHEREAS, the Assembly must approve an ordinance to accept and appropriate these grant funds; and

WHEREAS, no expenditures can be made until the scope of work and budget has been approved by the Assembly; and

WHEREAS, the scope of work and budget are contained in Resolution Serial Number 07-115; and

BE IT ENACTED:

Section 1. Classification. This is a non-code ordinance.

Section 2. Acceptance. The Matanuska-Susitna Borough Assembly hereby accepts the amount of \$1,395,000 from the Alaska State Department of Commerce, Community and Economic Development.

Section 3. Appropriation source. The Matanuska-Susitna Borough Assembly hereby appropriates the amount of \$1,395,000 to the following:

1) Repairs to an out-building at Station 81, wildland shelters, fire fighting equipment and personal protective equipment for Big Lake Station 81.

Fund 405/project 45226 \$30,000

2) Purchase two four-wheelers, two snow machines, communication equipment, fire fighting equipment and personal protective equipment for Butte Fire Service Area.

Fund 405/project 45227 \$75,000

3) Purchase office and training room furniture, hose, nozzles appliances, personal protective equipment, forestry shelters and other miscellaneous fire response equipment for Meadow Lakes Fire Service Area.

Fund 405/project 45228 \$30,000

4) Purchase communication equipment, training aids, fire fighting and safety equipment, personal protective equipment and self contained breathing apparatus for Talkeetna Fire Service Area.

Fund 405/project 45210 \$30,000

5) Purchase a 100 foot aerial ladder platform apparatus and related equipment for Wasilla-Lakes Fire Service Area.

Fund 405/project 45066 \$1,200,000

6) Make repairs and upgrades to equipment and apparatus, purchase fire fighting equipment, self contained

breathing apparatus, scene lighting and a canopy for Willow Fire Service Area.

Fund 405/project 45211

\$30,000
