MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 07-160

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING A \$91,093 UNITED STATES DEPARTMENT OF HOMELAND SECURITY, ASSISTANCE TO FIREFIGHTERS GRANT AND REQUESTING AN APPROPRIATION OF \$4,794 FROM THE BIG LAKE FIRE SERVICE AREA FUND BALANCE, FUND 256, TO PROJECT NO. 45141, FUND 405, TO PURCHASE SELF-CONTAINED BREATHING APPARATUS AND RELATED EQUIPMENT.

WHEREAS, the Borough has been notified that the Big Lake Fire Service Area has been awarded a grant from the United States Department of Homeland Security Assistance to Firefighters Grant Program; and

WHEREAS, the funds will be used to purchase self contained breathing apparatus and related equipment; and

WHEREAS, the fire service area is required to provide matching funds in the amount of \$4,794, in order to comply with the conditions of the grant and to receive the grant; and

WHEREAS, the scope of work and budget are contained in Resolution Serial No. 07-120.

BE IT ENACTED:

Section 1. <u>Classification</u>. This is a non-code ordinance.

Section 2. <u>Acceptance</u>. The Matanuska-Susitna Borough Assembly hereby accepts the amount of \$91,093 from the United States Department of Homeland Security Assistance to Firefighters Grant Program.

Section 3. <u>Appropriation source</u>. The Matanuska-Susitna Borough Assembly hereby appropriates the amount of \$91,093 from the United States Department of Homeland Security Assistance to Firefighters grant no. EMW-2007-FO-10528 and \$4,794 from the Big Lake Fire Service Area Fund Balance, fund 256, to fund 405, project no. 45141, to purchase self-contained breathing apparatus and related equipment.

Section 4. <u>Effective date</u>. This ordinance shall take effect upon adoption by the Matanuska-Susitna Borough Assembly.
