To Whom it May Concern:

These are my public comments on the Draft Plan for Settlers Bay Coastal Park.

I wholeheartedly support the placement of the Conservation Easement on the property, the establishment of Settler's Bay Coastal Park, and the Draft Plan. The Draft Plan conforms to the Conservation Easement and strikes an appropriate balance between access and protection.

I just have a few comments.

First, the vision statement provides, with one exception, appropriate overarching guidance for the management and use of this area. However, I question the use of the term "adventure playground" to describe the property. "Adventure playground" is a meaningless term in this context, as it can be interpreted to mean just about anything (including an ATV obstacle course, for example). To be consistent with the rest of the vision statement, management intent, the character of the property, and the Conservation Easement, I suggest the words "... in a natural setting," replace "in an adventure playground."

Second, I think it would be helpful, (under "Existing Conditions" "Topography" subsection, perhaps in the "forested uplands" sentence, to describe the species of trees.

I hope that there are no roads built, nor motorized vehicular use allowed, in the planning area.

Basically, it is a good plan that is consistent with the Conservation Easement and will guide management policy on into the future. I hope it is approved.

Thank you for this opportunity to comment.

To whom it may concern,

A variety of published and unpublished resources indicate that a historic trail or trails that were later identified and designated as part of the Iditarod National Historic Trail system are found within the parcel(s) under consideration in the Settlers Bay Coast Park Development Plan. I am writing to recommend that the plan recognize these historic uses, and accommodates any historic or cultural landscape features that may remain in the parcel.

(Note that designation of the Iditarod National Historic Trail system did not confer any rights of management to the BLM, although development of lands affecting historic resources are subject to the National Historic Protection Act, and other existing laws.)

I've included several unpublished maps and chronologies that display the approximate location of historic trails in the vicinity of the subject parcel (and further information is commonly available). As seen on the "GLO Township Survey Maps" attached, the trail(s) known as the Knik to Cottonwood Winter Trail cross the parcel. Note that while RST 1710 Wet Gulch Trail may include a branch of the Knik to Cottonwood Trail on the coastal wetlands below the forested uplands, it appears that there may have been another alignment of the same trail located in the uplands that are now under consideration for the Coastal Park (it was a common historic practice to provide alternate routes to avoid high water events and other intermittent trail obstructions).

The draft Coastal Park Development Plan shows the installation of winding loops of recreation trails, and a scenic overlook, toliets, and picnic facilities south of an east-west road that is currently gated at the east end of Settlers Bay Drive (identified as a "Limited Development Area"). In order to prevent destruction of any historic or cultural landscape features, especially in the area south of the above-mentioned road, I'd recommend a careful cultural survey of ground-features before further site planning and construction takes place.

While I recognize that this area may have been previously disturbed by the previous owners and the intention may be for adaptive re-use of disturbed areas, this site area may have a number of

unrecognized cultural features that should be maintained (there is a possibility that there are a number of pre-Euro contact indigenous structures in this area, such as found throughout the bluffs overlooking ADFG access to Cottonwood Creek two miles to the east.)

As necessary, I'd recommend that the Limited Development Area be designed as a "floating" polygon that can be located so as to avoid sensitive cultural features. And if historic trail landscape features are discovered in the area, it may be possible to incorporate sections of modern trail on those alignments, and convey via interpretive signing that recreationists are following historic routes. To this end, BLM can offer the use of the federal insignia for the Iditarod National Historic Trail on both trailside markers and interpretive graphics.

I would also recommend the "telling of the story" of the native uses and historic trails that crossed this area, as one of of the interpretive themes for interpretive panels that will likely be considered for the overlook.
