State Forestry Stewardship Program: The Alaska forest stewardship program for private landowners with forest concerns is available on the Division of Forestry & Fire Protection website here: <a href="https://forestry.alaska.gov/stewardship/">https://forestry.alaska.gov/stewardship/</a>. With Federal assistance from the U.S. Forest Service, the State can provide technical assistance to develop plans to address forest health on private lands. There are also grant opportunities with a 50% match requirement to implement the specific forest health plans for forests on private lands. RE: Questions from June 6, 2023 Assembly Hearing

Dear Mr. Brown,

The following are responses from Division of Forestry and Fire Protection staff to questions asked by Assembly members in the meeting on June 6<sup>th</sup>:

How many timber sales does the state produce? The state sold 23 timber sales in 2022.

**How many salvage sales?** A summary of salvage sales for the last five years are attached. Note the two separate sections: Salvage Sales under Alaska Statutes 38.05.117 and Salvage Sales under Alaska Statutes 38.05.115 or Alaska Statutes 38.05.120. The latter is where "salvage" appears in the name but the sale went out as either small negotiated (.115) or competitive bid (.120).

Also of note, in addition to the commercial timber sales in the Mat-Su, since 2020 we have sold 34 personal use sales of beetle killed trees in the Mat-Su. Most are used for firewood but a few have been for sawlogs and a few for house/cabin logs.
