## **MEMORANDUM**

Junk and Trash Free Drop-off Program Summary: The free disposal was available for Borough residents from September 16 to September 30, 2023. There were record numbers of customers, with some days exceeding 800 customers, averaging 698 customers per day. Normal days average approx. 450 customers per day. The volume of waste disposed of during this period increased by 160 tons per day from the average of 220 tons per day, or 380 tons per day during this free disposal period. The total tonnage collected for all commodities was 5,703 tons. Total number of customers serviced was 17,878. The total fiscal impact to the Landfill, including lost revenue, costs to operate, and contractor expenses, was \$891,120. See below for a breakdown.

**Brett Memorial Ice Arena Lighting Upgrade:** There have been numerous comments from the public about how nice the new LED lighting turned out at the Brett Ice Arena. Public Works staff were able to convert the facility lighting for less than \$7,000 in material. Each new light has an estimated savings of \$118 per year, which could yield up to \$6,000 in energy savings in the first year.

<u>Seward Meridian Parkway Phase II Update</u>: On Monday, October 23, ADOT&PF reported that the Seward Meridian Parkway Phase 2 project was still waiting on the completion of all the utility agreements. ADOT&PF expects that once the utility companies shift out of summer construction mode, they will finish the agreements, and the project will be advertised in December.
