

Landfill Coupons: Our new process to distribute \$25 landfill discount coupons this year is outlined on the Solid Waste website: <u>https://solidwaste.matsugov.us/pages/news</u>. Online applications will be accepted until May 31, 2024, and the coupons will be valid for one year. The reason for limiting the application window is so that staff do not have to dedicate time to validating coupons over the course of an entire year.

Fish & Wildlife Commission Quarterly Report:

During the first quarter of 2024, the MSB Fish and Wildlife Commission (FWC) met five times as follows:

January 11: Regular meeting

Providing Outstanding Borough Services to the Matanuska-Susitna Community

- January 30: Special meeting Board of Fisheries Planning, Federal Fishery Management, Susitna Basin Recreational Rivers Plan Update, and Island Lake Float Plane Development
- February 5: Special Meeting Board of Fisheries Planning
- February 8: Regular Meeting
- March 21: Regular Meeting

The FWC spent much of January and February planning for and participating in the Board of Fisheries (BOF) Upper Cook Inlet Finfish meeting. Members also traveled to Seattle for North Pacific Fishery Management Council meetings regarding federal fishery management in the Exclusive Economic Zone (EEZ) of Cook Inlet, and to Juneau to advocate for full funding to ADF&G for weirs and scientific studies in our region. Additionally, the FWC has been developing questions to submit to Alaska Department of Fish & Game (ADF&G) ahead of the FWC/ADF&G Game Season Summary meeting that is scheduled in the Assembly Chambers on June 6, 2024. They have also requested a Game Harvest Report along the same timeline. The FWC has discussed and submitted comments regarding the Susitna Basin Recreational Rivers Management Plan update, is currently considering involvement in the 2025 Board of Game meetings to be held in Wasilla and Anchorage next winter, and has had introductory conversations with ADF&G wildlife biologists regarding Moose Safety lighting.
