**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 25-087**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING MSB 5.25.044(A), SERVICE AREA NO. 27: MEADOW LAKES ROAD SERVICE AREA; AND PLACING ON THE BALLOT OF THE NOVEMBER 4, 2025, REGULAR BOROUGH ELECTION THE ANNEXATION OF PARCELS LOCATED ON W. MANA NAEN STREET, W. ELVAS LANE, AND A PORTION OF N. UTOPIA VIEW CIRCLE INTO THE MEADOW LAKES ROAD SERVICE AREA.

BE IT ENACTED:

Section 1. Classification. This ordinance is of a general and permanent nature and shall become a part of the Borough Code.

Section 2. Amendment of section. MSB 5.25.044(A) is hereby amended to read as follows:

(A) There is established Matanuska-Susitna Borough  
Service Area No. 27, known as the Meadow Lakes Road Service  
Area, more particularly described as:

Shall parcels located on N. Mana Naen Street, W. Elvas Lane, and a portion of N. Utopia View Circle, as shown on the map in the polling location and attached to IM No. 25-165, be annexed into the Meadow Lakes Road Service Area No. 27?

The anticipated cost of the services for the property to be annexed the first year is not expected to exceed 2.714 mills or \$271.40 per \$100,000 of the assessed valuation.

Services shall commence July 1, 2026.

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY FINDING THE ANNEXATION OF PARCELS LOCATED ON N. MANA NAEL STREET, W. ELVAS LANE, AND A PORTION OF N. UTOPIA VIEW CIRCLE INTO THE MEADOW LAKES ROAD SERVICE AREA SERVES THE PUBLIC INTEREST AND PLACING THE QUESTION BEFORE THE VOTERS IN THE NOVEMBER 4, 2025, REGULAR ELECTION.

WHEREAS, a petition has been certified by the Clerk requesting the annexation of parcels located on N. Mana Nael Street, W. Elvas Lane, and a portion of N. Utopia View Circle into the Meadow Lakes Road Service Area; and

WHEREAS, the petitioner gathered the signatures of 50 percent of the real property owners in the area, which meets the requirements of Borough code; and

WHEREAS, the Meadow Lakes Road Service Area Board of Supervisors reviewed the request and their recommendation is attached to the informational memorandum; and

WHEREAS, the Manager finds that the public interest will be served by the annexation of these parcels into the Meadow Lakes Road Service Area; and

WHEREAS, State Statute and Borough code require that this type of annexation go to the voters within the existing service area and to the voters in the proposed annexation area; and

WHEREAS, the annexation will be placed before the voters within the existing service area and in the area proposed for annexation at the November 4, 2025, Regular Borough Election.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly approved the annexation of the property located on N. Mana Nael Street, W. Elvas Lane, and a portion of N. Utopia View Circle into the Meadow Lakes Road Service Area; finds the public interest will be served; and for the questions to be placed on the November 4, 2025, Regular Borough Election ballot to the qualified voters of the existing road service area and the area to be annexed.
