1. Board Of Fisheries 2024 Meeting Goals & Proposals

MW recognized Kevin Delaney, KRSA, to discuss their BOF work. Kevin Delaney, Kenai River Sportfishing Association Priorities:

1. Adjust sockeye goals in Kenai river to accomindate the various users, but to also to flex upward marginly when needed to prevent overharvest.

2. Careful management of king salmon with an OEG that will allow the stock to grow, and in the setnet fishery using effective selective harvest strategies.

3. Maintain integrity of the conservation corridor; recommends FWC focus on this; and getting salmon into the northern district; maintain the PU fishery in the Susitna and consider expanding that opportunity.

- KRSA is looking at five areas to submit proposals.
- Would like to work with setnet fishers in the upper district to develop selective harvest strategies; for example to incentivize shallow net gear.
- Would like a flexible OEG for late run sockeye salmon; adding across the abundance strata when conditions allow, giving managers some flexibility.
- Commissioner DVL through EO has lengthened the Friday opener to about 60 hours; will recommend this be reduced to a 48 hour window.
- Develop a draft Kasilof king salmon mangagement plan.

Would like to emphasize to the FWC to carefully watach that the Conservation Corridor concept is maintained in BOF24.

LE: appreciates Kevin being here, and is looking forward to working with KRSA. PP: would echo LE's comments; when you mention extending the window, what do you mean? KD: DVL has taken position that PU fisheries should be nutured.

BOF 24 Meeting Goals:

Thank you for following up regarding the Cook Inlet Salmon agenda item.

At the December meeting, the Council conducted its initial review of the Cook Inlet Salmon FMP Amendment analysis, which evaluates alternatives to manage salmon fishing in the Federal waters of upper Cook Inlet. The analysis describes and evaluates the impacts of the four management alternatives under consideration by the Council, noting that two of these are not viable based on court decisions. For the next version of the analysis, staff will provide additional details on Federal oversight and other operational details that would result from implementing Alternative 2 or 3. The Council elected not to select a preliminary preferred alternative at this time, and anticipates taking final action on this amendment at

the April 2023 Council meeting.

The Council recommends releasing the analysis for a new amendment to the Salmon FMP for public review and anticipated final action at the April 2023 Council meeting. This action is necessary so NMFS can implement an FMP amendment by the May 1, 2024 court-ordered deadline. The Council is not selecting a preliminary preferred alternative at this time.

Purpose and Need (unchanged from the Council's October 2022 motion)

The Council intends to amend the Salmon FMP to manage salmon fishing in the Federal waters of upper Cook Inlet. Federal management must be consistent with the Magnuson-Stevens Act, including the required provisions for an FMP specified in section 303(a). This proposed action is necessary to bring the Salmon FMP into compliance with the Magnuson-Stevens Act consistent with the 2016 Ninth Circuit decision and the recent summary judgment opinion of the Alaska District Court in UCIDA et al. v. NMFS.

<u>Alternatives</u> (unchanged from the Council's October 2022 motion except for adding the options summarized below)

Alternative 1: No Action.

Alternative 2: Federal management of the fishery in the EEZ with specific management measures delegated to the State.

Option 1: Delegate recreational salmon fishery management measures to the State (as described at Section 2.4.3, pg. 81) and include monitoring, recordkeeping, and reporting measures (as described at Section 2.4.8.2, pg. 97) as well as standardized bycatch reporting methodology for the recreational fishery (as described at Section 2.4.9, pg. 98).

Option 2: Establish a peer review process that works in conjunction with the SSC as an option for an Annual Process for Determining the Status of the Stocks (as described in Section 2.4.7, pg. 91).

Option 3: Streamline the process to determine the status of stocks and set harvest specifications as a sub-option for an Annual Process for Determining the Status of the Stocks (as described in Section 2.4.7, pg. 94).

Alternative 3: Federal management of the fishery in the EEZ.

Option 1: Define optimum yield in terms of a range of annual catch limits (as described at Section 2.5.5, pg. 109).

Option 2: Streamline the process to determine the status of stocks and set harvest specifications as a sub-option for an Annual Process for Determining the Status of the Stocks (as described in Section 2.5.6, pg. 111).

Option 3: Adopt recreational salmon fishery management measures (as described at Section 2.5.9, pg. 113) and include monitoring, recordkeeping, and reporting measures (as described at Section 2.5.7.2, pg. 113) as well as standardized bycatch reporting methodology for the recreational fishery (as described at Section 2.5.8, pg. 113).

Option 4: Fix a commercial salmon fishery closure date for the Cook Inlet EEZ as an option for establishing commercial fishing periods (as described in Section 2.5.11, pg. 94). Evaluate July 15 as a potential closure date, as well as a range of other potential closure dates in July.

Alternative 4: Federal management of the commercial fishery in the EEZ with the EEZ closed to commercial fishing.





King and Silver Salmon are the economic drivers of Mat-Su sport fisheries

Direct spending on MSB sport fisheries fell from \$141 million in 2007 to \$57 million in 2017, a decrease of 59%

In 2014, a 7-0 vote at the Alaska State Board of Fisheries set in motion a sea of change in how the commercial fisheries are managed in Upper Cook Inlet under the Central Drift Gillnet Management Plan. Regulatory teeth were put in place that allow more northern bound fish to pass through a gauntlet of commercial fishing nets, into the Mat-Su Basin, where the shallow braided river channels and sloughs challenge even the toughest of returning salmon.





Enhance the Conservation Corridor in the Central District.

Increase State funding for fish weirs located in the MSB and increase genetic sampling to improve salmon management

Hold State Board of Fish meetings at a neutral site, such as Anchorage, rather than in the MSB or Kenai Peninsula Borough

Fully match Federal funds from license fees to maximize Federal dollars for Fish and Game

Continued improvements to the MSB fish passage culvert program.

Support collaboration between the State and Federal management to reduce bycatch.
