A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH PARKS, RECREATION AND TRAILS ADVISORY BOARD IN SUPPORT OF WOLF LAKE PARCEL P-08B REMAINING AVAILABLE FOR PUBLIC USE.

WHEREAS, Parcel P-08B, commonly referred to as the Wolf Lake Parcel, has long served the public as a valued recreation and access point under the stewardship of the State of Alaska; and

WHEREAS, the Wolf Lake area has experienced significant residential growth, now comprising more than 2,000 homes, resulting in a marked increase in demand for accessible, high-quality public recreation spaces; and

WHEREAS, Parcel P-08B is the only existing lake-access site in the region that is available for general public use, and the loss of this parcel would eliminate the sole opportunity for lake-based recreation for area residents; and

WHEREAS, the North Lakes Community Council conducted a comprehensive survey of local property owners, with an overwhelming 93% of respondents expressing support for preserving the parcel as a designated community park, thereby demonstrating substantial public consensus and community will; and

WHEREAS, the State of Alaska is actively considering the sale of publicly owned parcels in this area for private development, a course of action that would permanently preclude future public use

and recreation on this critical site; and

WHEREAS, preserving Parcel P-08B aligns with the Matanuska-Susitna Borough's Comprehensive Plan goals to ensure equitable access to outdoor recreation, promote quality of life, and support the health and wellness of its growing population;

NOW, THEREFORE, BE IT RESOLVED, that the Matanuska-Susitna Borough Parks, Recreation, and Trails Advisory Board strongly urges the continued protection and designation of Parcel P-08B at Wolf Lake for permanent public use and recommends that all relevant agencies take the necessary actions to retain this parcel in public ownership for the benefit of current and future residents.

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH PARKS, RECREATION AND TRAILS ADVISORY BOARD RECOMMENDING APPROVAL OF AN ORDINANCE AMENDING MSB 17.02 - MANDATORY LAND USE PERMITS, MSB 17.55 - SETBACK AND SCREENING EASEMENTS, MSB 17.65 - VARIANCES, AND MSB 17.125 - DEFINITIONS.

WHEREAS, the 75-foot waterbody setback was originally established in 1973 by assembly ordinance; and

WHEREAS, the setback was temporarily reduced to 45 feet in 1986 but reinstated to 75 feet by voter initiative in 1987; and

WHEREAS, over time, enforcement of the 75-foot setback has been limited, resulting in widespread noncompliance, environmental impacts, and real estate complications; and

WHEREAS, between 1987 and present, over 700 shoreline structures have been built in violation of the 75-foot setback ordinance, many of which went undetected due to limited permitting requirements and enforcement options; and

WHEREAS, Ordinance 25-073 offers a pragmatic solution by allowing structures to be built within 75 feet of a waterbody, provided they are designed and built in accordance with plans

developed by a qualified professional that ensure water quality is protected; and

WHEREAS, the Matanuska-Susitna Borough (MSB) continues to experience sustained residential, commercial, and recreational development near its lakes, rivers, and wetlands, increasing the need for clear land use regulations to manage growth while protecting environmental resources; and

WHEREAS, waterbodies in the MSB provide significant public benefits, including clean drinking water, fisheries, recreation, scenic values, and ecological services that can be negatively impacted by unmanaged development, impervious surfaces along waterbodies, and pollutant discharges; and

WHEREAS, Ordinance 25-073 requires land use review and permitting procedures for mechanized development within 75 feet of a waterbody, providing the MSB the opportunity to evaluate drainage and infiltration in order to protect water quality; and

WHEREAS, the ordinance develops several new general standards for development within 75-feet of a waterbody to ensure pollution is minimized.

NOW, THEREFORE, BE IT RESOLVED, that the Matanuska-Susitna Borough Parks, Recreation and Trails Advisory Board hereby recommends Assembly adoption of Ordinance 25-073.

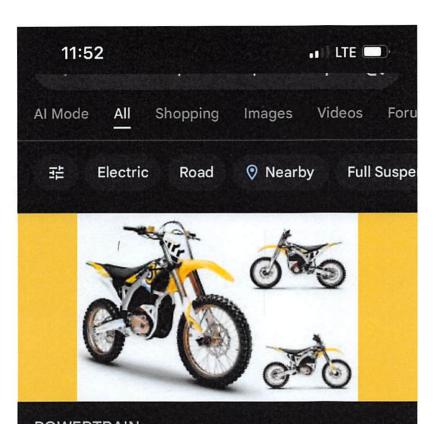

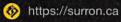

Donation Amounts and Duration;

The price of a donation includes the purchase of a new bench or the refurbishment of an existing bench, an initial bronze plaque, installation, and fifteen years of routine maintenance and repairs.

After the fifteen-year period, existence and/or maintenance is not guaranteed, and the disposition of the gift is at the sole discretion of the Matanuska Susitna Borough. If the bench needs replacing the Borough will contact the donor for first right to re-donate.

- 1. \$1,500 for a wood or recycled plastic new Parks Standard bench.
- 2. \$1,000 for adoption/donation to refurbish an existing park bench.

B. Approved Bench Locations

- 1. The Matanuska Susitna Borough has prepared a list of pre-approved bench locations. Benches may only be installed on pre-approved locations.
- 2. Donations of new park benches will only be accepted at pre-approved bench locations for the Parks/Trails where they have been provided.
- 3. All other placement locations shall be approved by the Community Development Staff.
- 4. We understand you may have a special place you would like the bench installed. We welcome your suggestion and desire as to where you would like the bench and will consider the location after staff review.

C. Plaque Guidelines

- 1. User provides plaque and will be made of bronze and must be 2.25" x 8". The plaque will be inserted onto the backrest of the bench.
- 2. The options for the wording on the plaque are: In [LOVING [use or omit]] Memory of [NAME OF DECEASED], a(n) [CHAMPION, ADVOCATE, [and] OUTSTANDING VOLUNTEER [Choose one, two or all] for our Borough [PARKS AND/OR TRAILS [choose one or both options]].
- 3. It is the responsibility of the donor to apply correct grammar and punctuation before engraving and placement of plaque.
- D. Timeline: bench and plaque order, delivery, install, and donation life span
 - 1. Refurbished benches- approximately two months.
 - 2. New benches- approximately up to four months and installed in fall and winter seasons.
 - 3. Your donation bench has the lifespan of fifteen years of maintenance and upkeep. Thank you for your consideration and thoughtful donation to our community.
