Is the material in good condition or appearance?

- The Trapper Creek and Talkeetna books are currently checked out and the condition of the books are unknown as of the time of this report.
- Big Lake has two books of this title. Both are in average condition.
- Sutton Library book is in average condition.

Is the topic of the material a priority for the collection?

The book is shelved in the Adult Fiction section at each library. This is a popular section among patrons of the Borough libraries.

Is the format of the material a priority for the collection?

The material is a book format. Books make up the majority of inventory in all five of our public libraries.

Has the material been used frequently by patrons?

- Trapper Creek added to title to the collection in June 2023 and it has been checked out a total of 7 times. Which is a moderately high rate of use.
- Big Lake added the first book to the collection in October 2022 and it has been checked out 21 times. This is a high rate of use. The second book of this title, a Large Print Version, was added to the collection in January 2024 and has been checked out 4 times this is a moderately low rate of use.
- Talkeetna added the book to the collection in April 2023 and has been 13 times which is a moderate rate of use.
- Sutton added the book to the collection in February 2022 and has been checked out 28 times. This is a very high rate of use.

Is the material factually accurate?

This is a novel and is fiction.

Has the material been superseded by a new edition or a better source?

None have been identified.

Is the material relevant to the needs and interests of the community?

Adult Fiction is a popular genre of materials checked out at Borough Libraries.

Can the material be easily borrowed from another source?

It is available at all the Borough libraries through our participation in the State Library Catalog as well as an E-Book through the Alaska Digital Library.

What is the literary, artistic, scientific, political, or educational merit of the material.

The primary purpose of adult fiction is to entertain and engage readers.

Does the material have positive review(s) in one or more appropriate professional journals?

Reviews are typically done in professional journals soon after the publication of the book and rarely are works of fiction reviewed in professional journals. Analysis or discussions on the book can be found online.
